Associate Financial

Assistance:

Digital Mammography:

A mammography system in which the x-ray film replaces solid-state detectors that convert x-rays into electrical signals. Signals are used to produce computer images of the breast that are stored electronically. This allows the radiologist to adjust the resolution of the image, making easier, faster, and accurate interpretations for women with greater breast density. DM procedures are especially effective on women under the age of 50.
